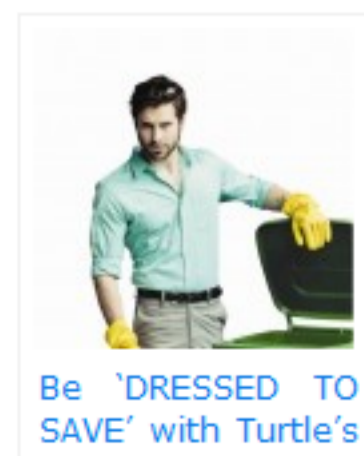
The specialty of these tamper evident envelopes/bags is that, if somebody tries to tamper by heating, cooling or using a solvent, it leaves an irreversible mark. What makes the product unique is the provision of bar-coding/sequential numbering helping to trace the contents and the chain of custody details printed on it, helping to keep the records intact

It is however often observed that the law enforcement agencies use paper bags, cloth, ordinary plastic bags to collect the evidences from the crime scene. The reason is absence of awareness on scientific evidence collection bags and availability of collection bags which are a global standard. As a result the evidences which are of (physical, chemical or biological nature) either get contaminated with other substances. On a serious note, there are even chances of them getting tampered as well resulting into a great damage to the case.

Speaking on the occasion, Mr. Gaurav Vora, Director, Dynaflex Pvt. Ltd., a visionary behind development of tamper evident line up in India says, "After years of extensive R & D, we have developed this technology, which leaves an irreversible proof of tampering. 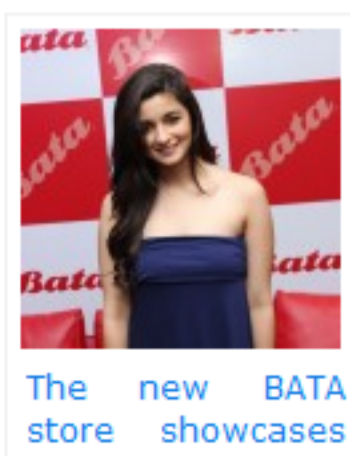

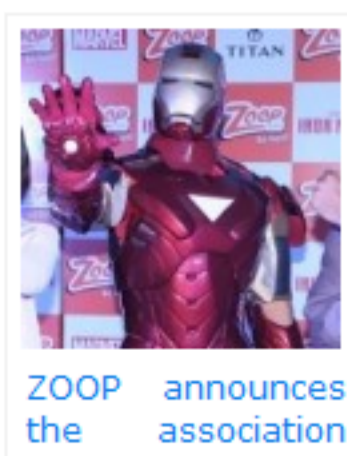
